**EFFECTIVE:** October 1, 2021

## I. BACKGROUND

The purpose of this change notice is to update the Food and Nutrition Services (FNS) benefit amounts for October 2021 due to the COLA. Changes were made to increase the regular FNS maximum allotment amounts, gross and net income limits. The Standard Utility Allowance (SUA), Basic Utility Allowance (BUA), Telephone Utility Allowance (TUA), standard deduction, and excess shelter deduction amounts also changed.

The Agriculture Improvement Act of 2018 contains provisions that includes changes mandated by law, that households in which all members are homeless, are now allowed a standard or excess deduction for incurred or anticipated shelter expenses. The homeless shelter standard deduction is \$159.73 per month.
