[] Sportsman/Coastal Recreational Fishing - Statewide hunting, inland and coastal recreational fishing. Includes hunting for big game, hunting on\$117 game lands, hunting for waterfowl (does not include the bear management e-stamp or federal duck stamp), fishing in designated Public Mountain Trout Waters, fishing in trout waters on game lands, and fishing in joint waters.
